Stockport is a large town in Greater Manchester, England, 7 miles south-east of Manchester city centre, where the River Goyt and Tame merge to create the River Mersey. The kiosks are located on Gréat Underbank on its junction with Little Underbank, outside White Lion. This location is the main retail thoroughfare of Stockport.

Description

These historic listed "K6" red phone box or "Jubilee" kiosks, commemorating the Silver Jubilee of the coronation of King George V. These boxes are 8'3" high and 3ft square. They were originally designed by Sir Giles Gilbert Scott, who also designed Liverpool's Anglican Cathedral, Battersea Power Station and Bankside Power Station now Tate Modern. In Cheltenham, 10 red phone boxes have been transformed into miniature art galleries, showcasing the work of local artists.
