Location

Linley is located just to the south of the attractive town of Broseley, 10 miles south of Telford, and just to the west of the A442 via Coalport Road.

Description

The property comprises a former distribution booster station and service reservoir upon an irregularly shaped, sloping site of approximately 0.148 hectares (0.366 acres). The property is bounded by the road to one side and on the other slopes down to the river cutting and is approached directly off the road via a gated service track. There may be development potential, subject to obtaining the necessary consents.

Utilities such as electricity and gas are available at the site although they have both been capped off. Telecoms are available in the public highway to the south of Linley Brook and water is available in the public highway fronting the site but has been capped off.
