It can be accessed via the A53 and A52 with the A500 (Queensway) providing direct access to the M6 motorway to the west via junctions 15 and 16. Stoke-on-Trent train station provides regional rail services as well as direct services to Manchester, Birmingham and London Euston. The site is located on Chell Street in a mixed use area opposite Eldon Street.
