#### Location

The site is located about 2.5 miles east of Glasgow City centre in the district of Haghill. Haghill is a neighbourhood in the city of Glasgow. It is situated in the east end of Glasgow, north of the River Clyde and is bordered by Alexandra Park to the north (with Riddrie beyond), Carntyne to the east, Dennistoun to the west and Parkhead to the south. Glasgow Kelvin College has a campus in Haghill. The site fronts Millerston Street, but also Bluevale Street to the west. Duke Street mainline Station is located within a short walk of the property.

### Description

A rectangular shaped site, previously used for advertising fronting the main roads as well as storage, totalling about 0.473 acres (0.192 hectares). The site may be suitable for a variety of different uses and possible development, subject to obtaining any necessary consents.
