Location

South Norwood is a south east London suburb lying about 8 miles south of central London. It is accessed via the A212, which links with the A23 to the north leading towards Vauxhall and central London. The area is well served by transport links with overland railway stations at Crystal Palace, Norwood Junction, Thornton Heath and Anerley as well as numerous bus routes that serve the area.

South Norwood Hill forms part of the A215 with the property forming part of an established retail parade on the west side of the road at its junction with Spa Close. The parade is home to a number of independent retailers as well as a Premier Express convenience store and national charity Mind.

Description

A mid terraced three storey building of traditional construction beneath a flat roof. The building is arranged as a ground floor cafe/restaurant with separate access from the front to a large three bedroom maisonette over first and second floors. The flat provides two reception rooms, kitchen and utility room on the first floor with three bedrooms plus a bathroom/WC on the second floor. The flat is in need of refurbishment. Externally there is off street customer parking to the front and to the rear there is a single storey attached garage.
