#### Location

Morecambe is a coastal town located some 4 miles north-west of Lancaster, 42 miles north-east of Blackpool, 31 miles north-west of Preston. The town has excellent road connections with the M6 (junction 34) being located about 6 miles to the east. The Property occupies a prominent corner position at its junction with Euston Road and Market Street, within the pedestrianised central shopping area. Nearby occupiers include Lloyds TSB, Burger King and Holland and Barrett.

## Description

This attractive Grade II Listed building is arranged on basement, ground and three upper floors totalling about 386.10 sq m (4,156 sq ft). There is a banking hall on the ground floor with ancillary offices and store room above. The basement has more store rooms with strong room. The property will be offered with vacant possession, but offers an opportunity for an investor/developer.
