Location

Lanark is an historic market town lying about 28 miles south east of Glasgow and 32 miles south west of Edinburgh and is accessed via the A72, A73, A706 and A743. Lanark railway station is within a short walking distance of the property and provides regional rail services including regular services to Glasgow and Edinburgh.

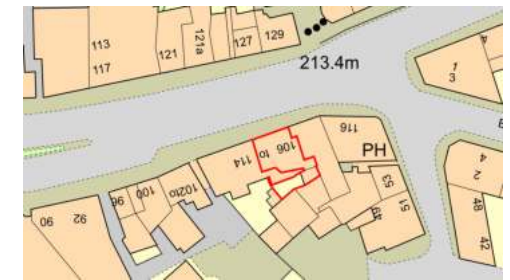
High Street forms part of the A743 and is the principal shopping thoroughfare in the town centre. The property lies on the street near its junction with Bannatyne Street. Nearby occupiers include WH Smith, Holland and Barrett, Subway, Nationwide and Card Factory.

Description

The ground floor only of a mid terraced two storey building of stone construction beneath a pitched roof. The ground floor totals approximately 62.24 sq m (670 sq ft) and is arranged as a front sales area with ancillary storage, kitchen facilities and WCs to the rear. The premises formerly traded as a bank under Class 2 of The Town and Country Planning (Use Classes) (Scotland) Order 1997 and as such a change of use to Class 1 (retail) is permitted but prospective purchasers are advised to make their own enquiries of the Local Planning Authority. There is a right of access to the close, with a right of access from the close to the yard and a right of access to the roof
